Privacy Policy

This Privacy Policy explains how Blue Wolf Dental ("we," "us," or "our") collects, uses, discloses, and protects your information when you visit our website [Your Website URL] (the "Site").

1. Information We Collect

We may collect personal information from you in several ways, including when you visit the Site, register on the Site, place an order, subscribe to a newsletter, respond to a survey, fill out a form, or interact with other activities, services, features, or resources we make available.

A. Personal Identification Information (Data you provide directly):

- **Contact Data:** Your name, email address, mailing address, and phone number.
- **Account Data:** Username, password, and other information required to set up an account.

B. Non-Personal Identification Information (Data collected automatically):

- **Usage Data:** Information about how you access and use the Site, such as pages visited, time spent on pages, and links clicked.
- **Technical Data:** Your Internet Protocol (IP) address, browser type, operating system, device information, and referring website addresses.
- **Tracking Technologies:** Data collected through cookies, web beacons, and similar technologies (see section 4).

2. How We Use the Collected Information

We collect and use your personal information for the following purposes:

- **To Provide Services:** To operate and maintain the Site, process transactions, and deliver the products or services you request.

- **To Personalize User Experience:** To understand how our users as a group use the services and resources provided on our Site, allowing us to tailor content and offerings.
- **To Improve Our Site:** To continually improve our website offerings based on the information and feedback we receive from you.
- **To Process Payments:** To complete purchases and provide the services you have ordered.
- **To Send Periodic Emails:** To send information and updates pertaining to your order, as well as occasional company news, updates, product information, or service information, if you have opted to receive them.
- **For Security and Fraud Prevention:** To protect the security and integrity of our Site and business.
- **To Comply with Legal Obligations:** To meet legal, regulatory, and compliance requirements.

3. How We Share Your Personal Information

We do not sell, trade, or rent your personal identification information to others. We may share generic aggregated demographic information not linked to any personal identification information regarding visitors and users with our business partners, trusted affiliates, and advertisers for the purposes outlined above.

We may share your personal information with:

- **Service Providers:** Trusted third-party vendors, consultants, and other service providers who perform services for us (e.g., payment processing, website hosting, email delivery, analytics). These parties are obligated to keep the information confidential and use it only to perform their services.
- **Legal Requirements:** When we believe release is appropriate to comply with the law, enforce our Site policies, or protect ours or others' rights, property, or safety.
- **Business Transfers:** In connection with, or during negotiations of, any merger, sale of company assets, financing, or acquisition of all or a portion of our business by another company.

4. Cookies and Tracking Technologies

Our Site may use "cookies" to enhance user experience. A cookie is a small text file placed on your hard drive by your web browser for record-keeping purposes and sometimes to track information about you.

- **You may choose to set your web browser to refuse cookies, or to alert you when cookies are being sent.** If you do so, note that some parts of the Site may not function properly.
